

**RESOLUTION FIXING ANNUAL BUDGET FOR HAMILTON TOWNSHIP FIRE DISTRICT NO. 4 AND CERTIFYING THE AMOUNT TO BE RAISED BY TAXATION IN SUPPORT THEREOF BY THE HAMILTON TAX ASSESSOR**

WHEREAS, at the annual election in Hamilton Township Fire District No. 4 held on February 20, 2016, the legal voters rejected the 2016 Budget as adopted by the Board of Fire Commissioners on January 14, 2016 in the amount of \$2,769,179.00; and

WHEREAS, pursuant to N.J.S.A. 40A:14-78.5.b, the Council of the Township of Hamilton shall review the fire district budget and conduct a public hearing at which any interested person shall be heard and fix an annual budget for said district; and

WHEREAS the Council has held a duly advertised public hearing(s) on March 5, 2016 for said purpose; and

WHEREAS the Council finds the modifications set forth below to be just and proper, and will not result in the impairment of the delivery of necessary and critical fire safety and protection services to the citizens residing in Fire District No. 4; therefore

BE IT RESOLVED by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey that the 2016 Annual Budget for the Hamilton Township Fire District No. 4 as rejected on February 20, 2016, be and is hereby revised as follows:
